## **IMPORTANT NOTES/INSTRUCTIONS**

- 1. Candidates not having domicile of Khyber Pakhtunkhwa are not eligible to apply for admission on Khyber Pakhtunkhwa seats.
- 2. All applicants must appropriately fill and sign the admission form and undertaking. Incomplete/not properly filled form in any respect will be rejected. Avoid rewriting/cutting, while filling the form.
- 3. The undertaking/agreement must be filled in by the candidate on Judicial Bond of Rs. 30/- and should be duly attested by the Political Agent/First Class Magistrate and attached with the application form. The specimen Performa for undertaking is attached with the application form.
- 4. Applicant must study the Admission Policy of Khyber Medical University in order to understand the Rules.
